A Week in Legal London, May 7-12, 2017

As consideration for being permitted to engage in The State Bar of California 2017 Litigation Section "A Week in Legal London" from May 7-12, 2017 (hereinafter "Program"), I, the undersigned, hereby voluntarily and of my own free will agree as follows:

1. Waiver of Liability, Assumption of Risk, and Indemnity Agreement

Waiver: I,, release, acquit and
forever discharge The State Bar of California ("State Bar"), its Board of Trustees, officers, sections,
committees, agents, employees, representatives, volunteers, contractors, subcontractors, assignees, as
same may be constituted from time to time hereafter FROM ANY AND ALL LIABILITY
WHATSOEVER, including but not limited to all claims, demands, obligations, liabilities, breaches of
contract, breaches of duty, acts, omissions, misfeasance or malfeasance, cause or causes of action and
otherwise of every type, nature, kind, or description whatsoever, whether heretofore or now existing or
which could, might be, or may be claimed to exist, all as if expressly set forth and described herein,
whether known or unknown, arising from or in connection with the Program, or any travel or
accommodations made incident thereto and FOREVER WAIVE AND FULLY RELINQUISH ANY
RIGHT TO SUE OR ANY OTHER CLAIMS OR DEMANDS that I may have against the State
Bar, arising out of or in conjunction with my participation in, or travel to or from the Program. I agree
to such waiver and release, whether any right or claim hereby relinquished arises due to the negligence
or other fault of the State Bar and/or any third party, whether due to dangerous or defective condition
of any property, facilities, or equipment, or whether the State Bar is subject to liability arising without
fault. I understand and agree that this release extends to and includes any and all damages, injuries and
claims which I do not anticipate or know about and I hereby expressly waive and relinquish any and all
rights under any law or statute to the contrary.

This release is governed by the laws of the State of California; and I hereby expressly waive the provisions of Section 1542 of the Civil Code of the State of California which states:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor."

Assumption of Risk: Participation in the Program carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but inherently subject me to risk of serious bodily injury or death. I HEREBY KNOWINGLY AND VOLUNTARILY ASSUME ANY AND ALL RISKS OF BODILY INJURY, PERSONAL INJURY, DEATH, AND PROPERTY DAMAGE OR LOSS WHICH MAY OCCUR DURING OR AS A RESULT OF MY PARTICIPATION IN THE PROGRAM, OR MY TRAVEL TO OR FROM THE PROGRAM, WHEREVER OR HOWEVER SAID INJURY, DAMAGE, OR LOSS MAY OCCUR, EVEN THOUGH AT THIS TIME I DO NOT

KNOW EXACTLY HOW EXTENSIVE ANY INJURY, LOSS OR DAMAGE MIGHT BE. I make this full and complete assumption of risk, regardless of whether all risks of loss are specifically enumerated herein, or are otherwise disclosed or known to me.

<u>Indemnification and Hold Harmless</u>: I further agree to protect, defend, indemnify and hold harmless the State Bar, its Board of Trustees, officers, sections, committees, agents, employees, representatives, volunteers, contractors, subcontractors, assignees from any and all liabilities, losses, demands, damages, claims, costs or expenses in any way rising from or in connection with the Program or any travel or accommodations made incident hereto. I further agree to reimburse the State Bar for any and all costs and expenses incurred (including attorneys' fees, costs and expenses) in connection with enforcing this indemnity provision.

<u>Severability</u>: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the laws of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
